Contribution/role of CSOs/PIs in the WASH sector

- Community mobilisation/development
- Capacity Building
- Construction/drilling
- Hygiene/Sanitation promotion
- Local governance
- Research/studies
- Knowledge Management

Rationale of developing a database of CSOs/PIs in the WASH sector

- Functions/contributions of GoG institutions and larger/well established CSOs and PIs are better documented and more visible
- Smaller CSOs / PIs' works less visible
- Need for comprehensive assessment to fully understand /position these actors – big or small - to have equal space to participate in all sector programs
- The assessment of CSOs and the private sector will serve as database for the sector information for monitoring and evaluation and also provide input into the preparation of the SWAp for the SSDP.

Rationale.....cont.

- Under the ongoing Sustainable Rural Water and Sanitation Project (SRWSP) a subcomponent will support the establishment of a robust Sector Information System (SIS) to facilitate information sharing, coordination, and to enhance M&E roles among WASH actors.
- The database on CSOs/PIs in the WASH sector is to be integrated into that SIS.

Objectives

- Ultimate goal recognize, acknowledge, standardize and coordinate their work for the greater benefit to the WASH sector in Ghana.
- General objective assessment of existing & future contributions of CSOs & PIs in the formulation, implementation, monitoring and evaluation of the WASH sector.

Expected outcome of assignment/impact on the sector

- Add to database of knowledge and experiences on their contribution to improve the WASH sector in Ghana
- Understand their challenges and;
- Explore what can be done to improve their effectiveness

Summary of type of information needed

- Complete list of CSOs/PIs in WASH & related sectors
- Types of WASH facilities/services provided quantity and quality of products.
- Projects they are working on & location
- Results they have achieved or plan to achieve
- How they work to achieve those results

Summary of type of information..

- Registration with relevant GoG agencies, DAs
- Existing capacities
- Future roles/responsibilities in line with future sector directions and reforms
- How they can be strengthened to be more effective development partners within the sector in the short and long term
- Their current and future funding sources and opportunities for resource mobilization

Categories of CSOs and PIs

- CSOs groups that are organised independently of, and operate outside of, but interact with the state and the market. They are voluntary, non – governmental and not for profit. They include:
 - Non-Governmental Organizations (NGOs) Local & International, FBOs, Social Movements, professional organisations, churches, Partner Organisations (POs) and Cooperatives - provision of soft & hard ware services
- PIs include: Companies contractors, drillers, consultants, etc - provision of soft & hard ware services

Sources of Information on CSOs & PIs

- National level "Master Lists"
 - -WSMP Directory of players in G WASH sector
- CONIWAS database -
- National/Regional CWSA
- Districts

Field experiences in the data collection

- It was realized that most of the organisations contacted and surveyed fell into the following categories:
 - Organisations with WASH background and currently active;
 - Organisations with WASH background which operated in some regions/districts but moved out on expiration of project;
 - Organisations with other orientations currently undertaking WASH programs;
 - Organisations with WASH background but inactive for lack of WASH programs/funding.

Field experiences.....cont.

- Some CSOs/PIs especially the funding-starved ones have expressed strong desire and willingness to partner government, CWSA, donors in bringing WASH programmes and services to the doorsteps of community members.
- Many have potentials that can be tapped, to make this survey and its intended database meaningful.

Field experiences.....cont.

- Non-responsiveness especially of PIs
- Most of the CSOs/PIs are in Accra
- Most NGOs in WASH are located in the regional capitals
- Some key MMDAs/organizations could not provide information on a single CSO/PI.

Conculsion

- The database of CSOs & PIs on WASH will be incorporated in Sector Information System to be housed in Ministry Water Resources, Works & Housing.
- The database will be updated on regular bases to ensure that all CSOs & PIs countrywide are captured.

- Getting the active CSOs/PIs in Accra will be crucial for the update
