The review was conducted in November/ December, 2021 with key sector stakeholder interviews to understand their perspectives on the relevance of the learning platform in facilitating dialogue and partnerships for improved sector performance in Ghana.

Ghana: National Level Learning Alliance Platform - Review highlights

Introduction

Learning Alliances are important multi stakeholder platforms for promoting individual, organizational and sector learning which can propel individual personal development, organizational development and sector-wide growth. Organizations must formalize the process of transferring good practices, including documentation and lessons learnt. Organizations must move beyond documenting good practices and lessons learnt, to putting in place a conscious system to ensure that new knowledge gathered is actually integrated into practice.

WASH Sector Learning Alliance

To advance the Water, Sanitation and Hygiene sector learning, the National Level Learning Alliance Platform (NLLAP) was established in October, 2009 by the IRC-supported Ghana Resource Centre Network (RCN) as the first ever knowledge management hub of Ghana's Water, Sanitation and Hygiene (WASH) sector. This platform brings different stakeholders together in a series of multi-stakeholder platforms at different levels (National, Regional and District) with the aim of creating innovative ideas around practical approaches to solve the challenges and improve sector performance. WASH Reflections paper is developed as a key outcome of NLLAP and circulated widely to WASH sector stakeholders. Having operated for over 12 years, IRC Ghana, the host of the RCN secretariat commissioned a review of the NLLAP to understand from stakeholders' perspective how the platform has enhanced sector experience sharing, learning and facilitating dialogue and partnerships for improved sector performance. Engage with partners on what they would like to see change to make it more effective to serve the WASH sector better.

Review Process

The process of review involved consultation with key stakeholders and twenty-two organizations, who were interviewed with a structured question guide. Key reports and documents were reviewed to augment the primary data findings. These elicited responses were synthesized and analyzed and key conclusions and recommendations drawn.

Key Findings

The findings revealed that NLLAP and the WASH reflections paper have been relevant and would continue to be relevant to serve sector knowledge needs if well positioned.

- The Government of Ghana, WASH sector actors, Non-Government Organizations in WASH, the Private Sector Organizations and WASH Consultants have used NLLAP reports and WASH reflections paper to shape policy development, proposal writings and project management activities at different levels.
- A NLLAP recommendation led to partner-supported nationwide dissemination of the strategic sector documents after the launch of such documents at the NLLAP session. This includes the USAID- Global Communities supported nationwide dissemination of the National Behaviour Change Communication Strategy and the National Strategy for Community Participation in Management of Urban WASH Services, among others.
- WASH stakeholders lauded NLLAP platform for providing the opportunity and space for networking and experience sharing, and in their opinion, this will remain relevant as the WASH sector moves towards the 2030 Agenda. They indicate that they used the platform for networking and dialogue on a range of issues including funding, collaborations, capacity building and building partnerships.
- With regular sharing from the NLLAP platform, stakeholders indicate that they are updated and able to self-assess ongoing work compared with new ideas and approaches that are introduced. This has enabled projects to obtain useful feedback from stakeholders from start, and contributes to new knowledge since models and approaches of implementation are shared. Through this, self-correction gets done to ensure successful implementation plans and attainment of desired objectives.
- Most stakeholders are willing to support in various ways to sustain the initiative. Some were of the opinion that the best option for funding the NLLAP is for projects to intentionally budget and commit portions of their project funds to sector learning. This means they should deliberately plan and budget for it to ensure an all-year-round fully funded NLLAP.

Sustainability of NLLAP

The sustainability of NLLAP and WASH reflections paper remain a key concern to stakeholders. Suggestions were made on how to ensure the long-term sustainability of NLLAP and host institution, RCN. This include the need for stakeholders to commit to a basket fund where agreed annual budgetary allocations are made by key stakeholders to fund NLLAP (and RCN) and collected on proportional basis at the beginning of each year. Another sustainability measure is to make a stakeholder or stakeholder groups who have findings, insights, innovations or policy issues to share at the NLLAP to cover the full cost of the meetings.

Changes were suggested to deepen the reach of the platform across the country. NLLAP should also be localized and hosted at regional and other zonal levels to increase participations of other Community-Based Organizations (CBOs) and Non- Governmental

Organizations (NGOs). This could be successful if the hosting or partnership arrangement is well discussed, such that the Community Water and Sanitation Agency (CWSA) or a well-established private sector agency or NGO is given the hosting and organization right on annual basis. The Organization interested in sharing any learning would fund the full cost of the platform at that level.

Interestingly, stakeholders are prepared to support in the dissemination of invitation, learning products, WASH reflection, setting up of benchmark to ensure the relevance of the content shared; and support to review proposals (learnings) brought up for sharing at NLLAP.

Conclusions

NLLAP is widely accepted as a sector platform for learning and knowledge management hub. As a result, the Ministry of Sanitation and Water Resources should provide the needed administrative, technical and financial resources to support NLLAP. With the leadership from the ministry, the NLLAP will further become an indispensable platform for sharing and reviewing relevant sector documents to inform sector know-how value.

An online version of the reflection paper should be circulated to sector stakeholders as part of the dissemination. An annual WASH reflection paper that highlights key innovations/ researches and the key recommendation made for all the NLLAP sessions for the year is good to explore. This should highlight key issues shared over the year to serve as a reminder and to enable stakeholders reflect over the past period in looking forward.

Identifying barriers to inclusion in WASH: This brief looks at how improved knowledge and skills in social inclusion are improving the capacity to identify excluded persons and advocate for WASH interventions to be accessible to all persons, especially for people living with a disability. It is based on a survey of 22 communities within Tarkwa Nsuaem Municipality, Ghana. The survey examined the characteristics of a random sample of 40 people living with a disability, and their environmental, institutional and attitudinal barriers to inclusion. The study concludes that in order to leave no one behind, decision makers and service providers need to examine common beliefs in measuring access to services.
