- Objectives
- to strengthen Awareness of Rights to WASH (in Schools) and strengthen skills and attitude in engaging in rights advocacy.
- to engage PTA/SMC, GES/Education Directorate, AMA/Sub-metros, MLGRD, MWRWH, Parliamentary sub-committees on the prioritization of School WASH facilities.
- to provide school and community advocacy teams adequate information to participate in meaningful interactions with WASH Sector stakeholders.

WATER SITUATION IN SCHOOLS

- 50% of the Schools don't have access to portable water.
- 25% have shared water sources. (This implies that schools fetch water from taps in other schools nearby or on the same compound)
- 25% have reliable water sources. (This implies there is consistent flow of water)
- 50% of the six schools' populations do not have access to water.

The challenges of those who have water include:

- High water bills for the Schools.
- Disconnection of water source due to lack of funds to pay water bills.
- Irregular flow of water and limited capacity to store water.

The challenges of those without water include

- Percentage loss of pocket money for drinking water on the part of pupils in schools without water connection.
- Lack of proper hygiene practices in the schools due to inadequate water.
- Frequent loss of instructional hours by girls especially during their menstrual periods
- Need to look for water to carry out WASH practices

TOILET SITUATION IN SELECTED SCHOOLS

- 33% of the Schools don't have access to toilet.
- 67% have toilet facilities but even that, they are inadequate.
- 17% of the pupils have no access to the toilet facilities due to the deplorable and unhygienic conditions in which they are.
- 50% of teachers do not have access to toilet facilities hence affecting teaching and learning.
- 50% of instructional hours are lost owing to nonavailability toilet facilities (In conversation with Teachers)
- The inadequacy of toilet facilities in the schools leads to child delinquency.
- Lack of maintenance of toilet facilities to disconnection of water.

HYGIENE SITUATION IN SELECTED SCHOOLS

- High rate of indiscriminate open defecation and urination on the various school compounds.
- Indecent exposure of female pupils during the process of attending to nature's call in the open.
- Indecent exposure on the part of teachers.
- Non-segregated Urinals for both teachers and pupils.
- Inadequate funds to dispose of waste or dislodge liquid waste.

REFUSE SITUATION IN SELECTED SCHOOLS

- Lack refuse dump Site in schools or closer to schools
- Indiscriminate dumping of garbage on the school compounds at night by dishonest community dwellers.
- Huge heaps of refuse on some school compounds resulting into environmental degradation.
- Burning of refuse on the various compounds due to lack of funds to dispose of refuse leading to environmental population.
- Inadequate bins to dispose or collect waste generated in the respective schools.

BASIS FOR SCHOOL WASH STATISTICS

• To establish the total number of children in the six selected schools whose right needs to be upheld.

• Thus;

- Percentage of aggregated score for indicators by the Total population of selected schools
- To support the demand for Recognition, Respect and Reaction to Rights to Water and Sanitation in Schools.

STATUS WASH FACILITIES IN SCHOOLS

TOILET

- 457- Children don't have toilet ready for use thus go out of school to attend to natures call
- 686- Children can't access toilet in school due to irregular water flow, non-functionality, and poor state of toilet in schools
- 686- children struggle for use of toilet in school due to limited stalls in most school toilets as well as stall structures.
- 457- children do not feel comfortable using toilets in school due to poor maintenance of school toilets.

WATER

- 686 school children are without water[[thus no pipe connection to schools]
- 686 school children don't have water available[travel outside their school for water]
- 686 don't have access to water[daily activities- flushing of toilet and handwashing]
- o 909 Schools don't have adequate water
 - [they share with other schools]
- 686 Schools don't enjoy acceptable water
 - [they use sachet water which is accounted as unsafe]

HYGIENE

686- Children don't enjoy reliable hygiene facilities in their schools i.e. soap and rolls 688- children can't access quality hygiene facilities and services –handwashing basins 1138 - children don't have adequate hygiene facilities and services to practice proper hygiene-few handwashing stands 909- children are using unacceptable hygiene facilities and services as required by G.E.S standards

REFUSE

- 909- Schools don't use dust bins for waste collection encouraging littering in school
- 1138 schools don't have access to facilities and services to practice waste segregation
- 1138 school population cannot be supported with current refuse facilities and services-level of waste generation on daily basis.
- 1138- school children are not addressing solid waste management in an accepted mannerburning of refuse.

CHALLENGES

- Fear of victimization on the part of school children and teachers for speaking out on WASH issues.
- Long bureaucratic process of seeking redress for improving poor WASH facilities

OBSERVATIONS

- Low level of participation of P.T.A and S.MC to advocate for improved WASH facilities and services in schools
- Inadequate monitoring of WASH facilities and service by school authorities i.e.. Circuit Supervisors, Heads of Schools and SHEP Coordinators
- Lack of Community Participation in the Provision and maintenance of WASH Facilities

RECOMMENDATIONS

- Stakeholders must demand from the newly established Water and Sanitation Ministry, a place in the WASH Budget to improve WASH facilities and services in schools.
- Ghana Education Service must lead the campaign on the supervision, operation and maintenance of WASH facilities in schools
- Parent Teachers Association and School Management Committee's must own up to their responsibilities as watchdogs on WASH services and facilities in schools
- CONIWAS as the national CSO in the WASH Sector must lead the campaign to uphold the Rights to WASH in schools.

CONCLUSION

The saying 'The Child Cannot Wait' is a valid statement that needs know argument. Children require a smooth and enabling learning environment to excel , the provision of quality WASH services and facilities play a vital role. We as stakeholders gathered here CANNOT wait but support and sustain their <u>CALL for WASH</u>
